

**TRAFFIC ACCIDENT IN FRANCE - FOREIGN VEHICLE RESPONSIBLE - GREEN CARD SYSTEM
OVERVIEW OF POSSIBLE HANDLERS ACCORDING TO FRENCH LEGISLATION AND INTERNAL REGULATIONS**

The chart attached shows the possible handling parties according to the French legislation and Internal Regulations, i.e., Green Card cases.

The chart does not include nor MID cases, neither the cases where Internal regulations and 4MID could both apply.

The injured party is allowed to claim against any body of his choice

It shows which organism can be competent, but it does not foresee the compensation. It is necessary to take into account the rules of intervention of each body or insurer (example : in case of unidentified vehicle, the French Guarantee Fund will not compensate the victim if there are only material damages, and so on ...)
